SITE INFORMATION:

All classes will be held indoors on artificial turf. Ring size is 73' x 115'. Exhibitors and spectators are expected to keep the entire area clean. Anyone witnessed not picking up after their dogs on the trial grounds will be excused from the trial with no entry fees refunded. No smoking in any of the buildings. **Building will be open at 6:30 AM both days.**

CRATING:

Ample indoor crating space is available in multiple rooms on two levels. Much of the crating space is on the 2nd floor. First floor crating space for those handlers physically unable to climb stairs can be secured in advance. Please contact Trial Chair, Donna Nisleit at plmrsyf@gmail.com. NO CRATES are to be brought into the ring area. Crates may be left overnight; however, K-9 OTC, Think Pawsitive, LLC, and Bluestem Agility Trial Services, LLC will not be responsible for any lost or damaged items left at the show site. Dogs may not be left overnight.

VIEWING:

For safety reasons, sitting is not allowed on the stairs near the rings. Additionally, dogs are not permitted to stand or wait on the stairs.

PARKING:

Parking will be available in the entire lot of the Think Pawsitive building. Additionally, the lot directly to the west is available for exhibitor parking as well -- watch for signs. Please do NOT park in the ABB lot to the east. There is no parking on the street.

EXERCISING YOUR DOG:

Please refrain from exercising your dog near any of the buildings. We ask that you use the ample grassy areas that are available.

Food will be available on site for exhibitors to purchase. There are also many restaurants within 5 minutes of the show site.
